## 5. Professional Characteristics

Law School is the only school to recruit bachelor degree, master degree and PHD in the Hubei University Of Economics.

Law school signed the international cooperation agreement with Pace University in the states, the students (from both law and social work) could get the Bachelor Degree in Hubei University Of Economics and the Master Degree in Pace University by 3+1 or 4+1 training methods.

## 6. Career Development and Employment

The major of law trains interdisciplinary, intelligent and moral talents who adjust to the socialist market economy and nation's law construction needs, have both good humanity and scientific qualities. They process strong fundamentals of law and proficient practical skills and they're good at the basic knowledge of economics, management science and practice of law in enterprise, judiciary and government so that they could do good job in these institutions. The graduates from Law School have 98% in employment rate, 90% in signature rate, 30% in acceptance rate for master studying, 30% in acceptance rate for national civil service. Most of them are employed in Wuhan, Shanghai, Guangzhou and Shenzhen.

The major of social work trains interdisciplinary talents of social work who are moral, intellectual, physical, aesthetic and labor educated. They have abundant basic fundamentals and strong professional skills of social work. What is more, they process basic knowledge of economics, management science as well so that they could do good job in enterprise, judiciary and government. The graduates from social work have 100% in employment rate, 35% in acceptance rate for master studying. Most of them works on management. They're well received around the society because of their high quality, strong competence, wide adaptability, high quality of employment.

# 1. Introduction to School of Law

The School of Law is composed of four departments including the Department of Basic Law, the Department of Economic Law, the Department of Sociology, and the Department of Practicing Work. It runs two undergraduate programs: law and social work. The School of Law has been permitted to train master postgraduate students jointly with the School of Law of Hubei University in 2012, and doctor students jointly with Zhongnan University of Economics and Law in 2015. The subject of law has been recognized as a Hubei key-cultivating subject of the 12th Five Year Plan, approved as a pilot program of comprehensive reform by Hubei Province, and supported as the principle of "Chutian Scholar Program" by Hubei Province. Sociology is also a key discipline at the level of HBUE. There are totally 530 students in the School of Law.

The School has a team of excellent teachers who are all professional and with full passion in their careers. 30 of them are full-time teachers-- 5of them are professors, 15 of them are associate professors. Further more, among academic leaders and academic backbones, there are 2 doctoral supervisors, 6 master supervisors. Besides, there are 3 post-doctors and 2 post-doctor candidates among the teachers.

The School of Law owns two streams of its discipline development: sustainable development law and sociology of law. There are four research institutions, including Hubei Research Center of Water Affair, Hubei Academy of Administration Review, Hubei Center of Cooperative Innovation for Ecological Civilization and Center for Local Law Studies. Teachers in the School have taken charge of more than 20 research programs, funded by the Ministry of Education and the provincial government. Publications include more than 30 books and 400 articles, at least 100 of which were published in national authoritative journals.

The School takes an active part in drafting, survey and examination of more than 30 local and national legislations, such as Environmental Protection Law of the People's Republic of China, Law of the People's Republic of China on Prevention and Control of Water Pollution, Law of the People's Republic of China on the Prevention and Control of Atmospheric Pollution, etc. A number of research achievements have been adopted by governments of all levels for decision making in legislations and policies.


